Primerica's Pre-licensing LLQP

To become a licensed life insurance representative, each candidate must complete the Life License Qualification Program (LLQP). The objective of the licensing process is to protect consumers by ensuring that each representative meets the minimum educational requirement prescribed by regulators.

The program consists of four modules:

Module 1: Life Insurance

Module 2: Accident and Sickness Insurance Module 3: Segregated Funds and Annuities

Module 4: Ethics and Professional Practice (Common Law or Civil Code)

The Primerica Pre-licensing LLQP is designed to provide the candidate with an opportunity to successfully complete the program when they meet the following expectations:

- Read Fundamentals of Life Insurance
- Attend the program's sessions
- Participate during the sessions
- Practice using the online study tools

Once the candidate has attended the program, they will be evaluated by writing and passing four certification exams which will allow the candidate to write the provincial LLQP exams.

Pre-licensing LLQP candidates will have support from their LLQP Licensing Coaches, who will lead them through the Pre-licensing LLQP Program.

Candidates are required to:

- Provide their CIPR number
- Provide a copy of a valid government-issued photo ID
- Read and agree to the LLQP Exam Code of Conduct

To ensure success, candidates should:

- Have their own personal subscription to full-service Primerica Online
- Register for SeeWhy Learning through the Primerica App or Primerica Online, once they have attended the first session
- Download the RapidPASS app and use on a regular basis to achieve a level of 3 trophies in each of the four modules
- Achieve at least a 60% on all the SeeWhy Learning practice exams prior to attempting the provincial exams.



Preparing for the Program

Steps to complete 3-5 days before the start of the Program:	✓	
1. Download the Primerica App		
2. Download and read the Fundamentals of Life Insurance (available on www.primericaonline.com>Go to Life Licensing>Pre-Licensing Education> Province>Register For Life Class>Life Student Pack).		
3. Download the RapidPASS App (Apple Store or Google Play) (access to the app will only be available for use once you have attended the first session).		
4. Download the Kahoot! App or go to <u>www.kahoot.it</u> and bookmark it.		
5. Create a CIPR profile. Go to <u>www.cipr.ca</u> and follow the steps to "register". Ensure to choose the appropriate Administrative Jurisdiction-Province.		
Steps to complete the day of the Program:	✓	
1. Complete the required pre-course reading from the Fundamentals of Life Insurance (if not yet done).		
2. Verify the address of the site or that your registration to the online sessions is completed.		
3. Bring valid government-issued photo ID and your CIPR number.		
4. Have a pen and paper ready to take notes.		
5. Be prepared to participate .		
Steps after the first day:		
1. Wait 6 hours (approximately) and log onto the Primerica App or Primerica Online to enroll for SeeWhy Learning and RapidPASS . NOTE: A full subscription to POL is required to access the LLQP online study materials including SeeWhy Learning (videos), the RapidPASS App and the CISRO manuals.		
Once all sessions are completed:		
Attempt all 4 Certification exams on the scheduled date.		
2. Pass all 4 Certification exams , ideally, within 30 days.		
3. Verify that your CIPR profile has been certified by the end of the next business day		
4. Register for the Provincial exams within 5 days of getting certified.
